

### A. PAYMENT REQUIREMENTS

- 1. A non-refundable reservation fee of \$500 on or before October 20, 2023
- 2. 2<sup>nd</sup> payment of **\$3,000** due on **November 17, 2023**
- 3. 3rd payment of \$1,890 + \$153 (Philippine travel tax, terminal fee and airline taxes, subject to change) due on January 12,2024
- 4. Travel insurance must be booked directly with Highlight Tours by January 12, 2024
- 5. Delayed payments shall be subject to a late fee of \$5 per person/day.
- 6. CCF reserves the right to cancel bookings in case of non-payment.

#### **B.** COSTS, INCLUSIONS & EXCLUSIONS

<u>Included</u>: Round trip economy class airfare; four/five-star hotel accommodations on twin sharing; daily buffet breakfast and dinner; five (5) lunches; entrance fees to all tour sites; luxury air-conditioned buses with licensed English-speaking tour guides; porterage of one (1) luggage/person <u>(strictly 1 luggage of 23kg/person)</u>; facilitation of entry permits and visas for Filipino citizens; gratuities for all hotels, guides, bus drivers and porters; border taxes; travel insurance

**Not included:** most lunches, passport fees; fees in obtaining visas for other nationalities; personal expenses (extra meals, mini bar, phone calls, business center fees, laundry, etc.); QUARANTINE HOTEL FACILITY, RT-PCR TESTING AND OTHER COVID-19-RELATED EXPENSES AS PRE AND POST-TOUR PROTOCOLS; hospitalization and medical expenses not covered by your travel insurance; transportation during free time, extension tours; business class upgrade; airport transfers for those not traveling with the group; and single occupancy. The list is not exclusive. All other provisions not included are deemed excluded.

#### C. ACCOMMODATION

- 1. All accommodations will be on twin sharing basis with rooms containing two beds. Participants requiring one double bed should specify their request at the time of registration.
- 2. If a single room is preferred, there will be an add-on rate of \$1,770.
- 3. If a single person traveling alone wishes to share a room with another person of the same sex, please indicate in the registration form that he/she is allowing the organizers to assign a roommate to him/her.

## D. CANCELLATION PROCEDURES & CHARGES

- The \$500 deposit is forfeited when a participant cancels his/her booking. This amount, however, may be assigned to someone else until January 20, 2024.
- After deposits and payments are made, cancellation and/or changes in your tour arrangements will warrant charges
  according to the following time frame:

Receipt of cancellation notice from:

Before December 20, 2023 \$500 deposit

December 21 to January 20, 2024 25% of the tour cost

January 21 to February 20, 2024 50% of the tour cost
February 21 to March 5, 2024 75% of the tour cost

March 6 to 23, 2024 100% of the tour cost

#### Tour cost = \$5.543

- Any cancellations due to Covid-19 sickness (mine or any in my traveling party), pandemic escalations, and failure to meet
  Covid-19 travel and safety protocols and/or vaccine requirements (current and/or updated at any point in the tour) in
  Egypt, Israel and Jordan will be subject to the above cancellation terms.
- Please accomplish your cancellation request in writing with accompanying medical certificates (if applicable) stating
  your reason for cancellation and submit to the CCF office before the departure date.
- Refunds will only be made available at the CCF office thirty days after the arrival of the tour group.
- Rebooking/reissuance of airline tickets after ticketing will cost \$150. No-show fee: \$150/person

# E. NO SHOW/UNUSED SERVICE/REFUNDS

No refunds will be granted for any unused services, missed meals and ungranted requests that would have otherwise been free and already included in the package price.

## F. CLAIMS & ADJUSTMENTS

Participants must immediately contact the CCF representative on the tour should any problem arise during the trip in order for us to resolve the problem before it escalates.

### G. RESPONSIBILITY

It cannot assume responsibility or liability for any loss, injury, delay, accident, or irregularity that may occur while carrying out the services of the contractors. The participant agrees that Christ's Commission Foundation, Inc. shall not be liable for any damage, loss (including personal injury, death, and property loss) or expense occasioned by any act or omission of any supplier providing tour services or any insurer, insurance of any other person.

The payment of deposit and a signature hereunder constitute a contractual agreement between CCF and the participant and represent consent to all provisions in the Terms and Conditions of this tour package.
